AN ORDINANCE AMENDING CHAPTER IV (ALCOHOLIC BEVERAGE CONTROL), SECTION 6-3 (LICENSES) AND AMENDING SUB-SECTION 6-3.4 (LICENSE FEES; MAXIMUM NUMBER) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY.

BE IT ORDAINED by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows: (additions are underlined, and deletions are in [brackets]):

Chapter IV, Alcoholic Beverage Control, Section 6-3 Licenses, Sub-Section 6-3.4 License Fees; Maximum

Number, is amended to read as follows:

6-3.4 **LICENSE FEES; MAXIMUM NUMBER.** The annual fees of licenses for the sale or distribution of alcoholic beverages in the Township shall be:

a. Plenary Retail Consumption License.....~~[\$2000.00]~~ \$2,500.00

Not more than three (3) plenary retail consumption licenses shall be outstanding at the same time within the Township, to be divided and allocated as follows:
