**Summer Recreation Camp-** Camp dates will be 5 weeks from June 3- to August 1st. Thirty camp counselors will be hired with a few alternates. Camp trips are being sold online; trips will be available online up to 1 day in advance. Same day trips can be purchased in the recreation office. Help is available for residents as we transition to paperless trip registration via the phone or in person in the office. Two buses will be used each day with a total of sixty trip combinations of all day, AM & PM being offered. Onsite activities will also be offered including Combat Sports, a music concert & a nature presentation. Camp registration is at 272 higher than in 2013. Chris Morris asked that an end of season email be sent to camp participants for feedback in improving the program.

**Men's Basketball-** Dom Ricci reported that there is bench at the Rocky Brook basketball courts in poor condition and asked that it be removed and if possible replaced. Men's Basketball will continue to use the Rocky Brook courts for the remainder of the summer.

**Warriors Basketball-** Terrence Murphy relayed to all that he expects 2 divisions this season consisting of 6 boys teams and 2 girls teams. Tryouts will be in early September in the Middle School; gyms dates, times and age groupings to be announced soon. He asked that when securing gym time that practice nights and gym consistency be requested.

**Pop Warner-** Sharon Peake informed the commission that Millstone will be combining teams with Allentown. As has been past practice she requested that the late fee be waived for nonresidents registering late. Practice will begin on Monday, August 4th and practice will remain at Wagner Farm Park. Practice will rotate between the upper & lower fields and field conditions will be closely monitored. The Wagner fields were well managed last year and with reduced enrollment and field rotation the impact on the fields should be minimal.
