**Summer Camp** - A summary was given to the commission regarding camp. Registration is continuing and staff is in place. Many trips have already begun to sell out. Preparations are all in place to begin setting up for camp the week of June 20th.

**Field Hockey** - C/Skowronski spoke to our program volunteer regarding the need for volunteers for the program. There was also some discussion with regards to practice location. We will

continue to practice at Abate Park for this year with the possibility of moving to Millstone Park in the future once construction is completed.
