Applicant sought variance approval to construct a covered porch and second floor proposing a 51-foot front yard setback for the second floor and 43.2-foot front yard setback for the porch where a minimum 75-foot front yard setback is required.

Z21-04 SCHERER, STEVEN & LOIS – Located at 1 Fern Drive, known as Block 54.01, Lot 1 consisting of 2.94 acres; located in the R-130 Zone. Applicants sought variance approval to install a 6-foot-high fence where a maximum fence height of 4 feet is allowed in the front yard.
