HIGHLIGHTS FROM THE TOWNSHIP CLERK'S OFFICE:

2021 DOG LICENSES: All dogs 7 months or older are to be licensed each year. The 2021 Dog Licenses can be purchased at the Municipal Building between 8:30 a.m. and 4:00 p.m. Monday through Friday in the Municipal Clerk's Office, Room 105 starting January 4, 2021. Due to the COVID-19 pandemic, please mail your fee along with proof of rabies and neutering/spaying to 470 Stage Coach Road, Millstone Twp., NJ 08510. Neutered/Spayed dog fee is \$12.00 and Non-Neutered/Non-Spayed dog fee is \$15.00. A late fee of \$10.00 PER DOG goes into effect May 1, 2021 for all residents who have not renewed their dog's license for the current year.

Millstone Township Fire District commenced providing Emergency Medical Services as of December 1, 2020



The Millstone Township Fire District officially took over providing Emergency Medical Services for Millstone Township residents commencing December 1, 2020. The Millstone Township Committee handed over the keys to a brand new ambulance that they had purchased and donated to the Millstone Township Fire District Board in a shared service agreement.

Due to Covid-19 epidemic, the presentation was very small. A more public ceremony honoring the occasion and the many former Millstone First Aid volunteers will be planned at a more appropriate time. This historic event was the culmination of years of declining volunteerism and the quality of services being provided to the residents.

There were many people involved in making this happen but Committeeman Mike Kuczinski, Lt. Mike Maloney & Lt. Alan South were instrumental in getting this accomplished. In addition, e-Bulletins will be used as another method to update residents in the event of an emergency or issuance of a municipal advisory such as road closures, down power lines or safety alerts. A Message from Monmouth County Health Department 3 KEY STEPS TO TAKE WHILE WAITING FOR YOUR COVID-19 TEST RESULTS

- 1. Stay home and monitor your health to help protect your friends, family and others. If you have been in contact with someone with COVID-19, stay home and away from others for 14 day after your last contact with that person. Monitor your health. Watch for symptoms of COVID-19 which may appear 2-14 days after exposure and can include: Fever or chills, cough, shortness of breath or difficulty in breathing, tiredness, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.
- 2. If you are diagnosed with COVID-19 a public health worker may call to check on your health, discuss who you have been around, and ask where you spent time while you may have been able to spread COVID-19 to others. Think about everyone you have been around recently. This will be important information to give health workers if your test is positive. For example, have you gone to work or school? Gotten together with others while dining, gone to a gym, had in person appointments, doctor, dentist, barber or salon? Have you had friends or family to your house or gone to their house, ridden in a car (Uber or Lyft) or taken public transportation? Been inside a church, synagogue, mosque or other places of workshop?
- 3. If a public health worker calls you, **answer the call** to help slow the spread of COVID-19 in your community. Discussions with the Health Department are confidential. Your name will not be shared with those you came in contact with. The Health Department will only notify people you were in close contact with (within 6 feet for more than 15 minutes) that they might have been exposed to COVID-19. Your personal and medical information will be kept private and only shared with those who need to know, like your health care provider.

Tips for Parents During This Stressful Time

Many parents think they are doing the right thing by trying to shield their children from stress and anxiety by hiding their own feelings. But research shows that children can usually tell when their parents or family members are under stress, no matter how hard they try to hide their own anxiety. Let's face it, the last months have been hard on everyone, but parents need to be mindful of their self-care needs so they are equipped emotionally to handle the anxiety and stress their children feel as they navigate through the life changes brought on by the COVID-19 pandemic.

The truth is, that it is not really possible or even the best thing to shield children from all stress and anxiety. And if parents don't manage their own negative and stressful emotions, they can actually transmit these to their children. Even very young children are sensitive and in-tune with their parents' emotional state.

In fact, by saying that everything is fine when it isn't parents send a mixed message that is confusing for children and sends the message that we should avoid feeling negative emotions or that we don't think they can handle upsetting news. This doesn't mean that we should share every detail of our stress with children or ever take out our stress on them, but discussing upsetting issues with children in an age-appropriate way can actually lay a strong foundation for helping children develop appropriate coping skills for the future and avoid negative coping skills such as substance misuse and aggression.

Being honest with them about your own stress in troubling situations is important. But don't share more information than is needed. By modeling positive ways that you handle stress and ways in which you practice self-care you are actually being a great role model of emotional resilience for your children. This is a skill that will serve them well as they navigate their own stresses and anxiety in the future. Have an honest and real conversation with your child and ask them what they are worried about. Then just listen.

This work is hard, and as parents we worry so much about our children and want to meet their every need. So parents here are some positive things you can do for yourself:

- 1. Prioritize physical health and activity.
- 2. Establish a routine for yourself and your family.
- 3. Have regular family meetings to discuss important issues.
- 4. Focus on what you can control.
- 5. Be kind to yourself, most importantly.

Official Notice: To Residents and Businesses of Millstone Township

Recycling is mandated by the State, County and Municipal Statutes.

All residents will separate newspapers, glass bottles and jars, tin and bi-metal cans, plastic containers, aluminum cans, corrugated cardboard for collection and ultimate recycling of materials.

Curbside Recycling Guidelines:

- Residential recycling is to be placed curbside on recycle days only before 6:00 AM. Recyclables should be placed loose in container 32 gallons or smaller. Please do not place your recyclables in a plastic bag, as they will not be picked up.

Clarksburg and the American Revolution

How many of you have driven down County Road 524 AKA Stagecoach Road in Clarksburg and knew that it was a major route to Philadelphia back during the 1700s? How many knew the Route mentioned was also used by British troops during the American Revolution on their way to Freehold Court House and the Battle of Monmouth? This is very true and the information I am about to share with you took place during the Revolutionary War right here in Clarksburg.

During the Battle of Monmouth Campaign, June 1778, British General Sir Henry Clinton evacuated the City of Philadelphia and started to march his army across New Jersey to Sandy Hook. There at Sandy Hook, Clinton could safely ferry his army back to New York City which had been occupied by British military forces and Loyalist since 1776. Before General Clinton approached Allentown, he had split his army in two sections. The first under General Cornwallis would proceed to Allentown and the second by General Knyphausen with his Hessian troops would protect Clinton's flank. At the end of the day General Knyphausen would reach Imlaystown and spend the night in a wheat field. General Clinton would arrive in Allentown and occupy the town.



The next morning, June 25th would be hot and very humid causing many casualties. Clinton marched out of Allentown on a road leading him on a rendezvous with Knyphausen at Imlayston. That road in question might be todays present I-195. After meeting up the British and Hessian column which stretched for some twelve miles with troops, wagons, and material marched on present County Road 524 (New Canton-Stone Tavern Road/ Stagecoach Road) to Clarksburg ,all the while being harassed by colonial militia.

When the British Army arrived in Clarksburg, General Clinton rested his troops. Using the Rising Sun Tavern as his headquarters, which was located on Route 524 AKA Stagecoach Road and Route 571 and no longer exists, his troops encamped on a field just across from the tavern. After a nights rest, Clinton proceeded with his army on Route 524 AKA Stagecoach Road reaching Freehold Court House (today Freehold Borough) that evening.

Today, Monmouth County Road 524 AKA Stagecoach Road is a well-traveled roadway and certain sections of it are protected land. In a few years the Country will be celebrating the 250th anniversary of the American Revolution and because of this, I am working along with the Millstone Township Historic Preservation Commission to have the British Route marked so that generations will know how important Clarksburg was during the Revolution War. With ongoing research, we hope to have the Rising Sun Tavern, the British campsite, skirmish locations, and Route 524 all marked with signs explaining what took place during the time of the Revolution War.
