## New Business

Discussed potential grant opportunities & partnerships:

ANJEC – an EC grant up to \$1500.00 which may be used for rain garden. Application is due 5/2/22. ET will partner with an EC member to pursue grant and begin planning rain garden on municipal property. ED will reach out to EC member to initiate contact. Small rain garden at Town Hall is likely location. Rain garden will be educational to encourage residents to build one on their property to address stormwater management.

NJ Shade Tree Federation – grant up to \$2,500.00 but only 1 awardee per year. This grant may be an opportunity when we plan arboretum.

ET discussed necessity of maintenance of future rain garden and arboretum. LR suggested STC work day once a year. Discussed possibility of using Master Gardeners and local arborists as volunteers to assist.
