C/Grbelja states that Memorial Day is a very moving day for her, we want to bring more people out but we do not want to see it become a carnival. We want to encourage people to come out and honor those who have served, those who have lost their lives and the families who have lost loved ones. This will be to assist our Veterans Council and not change the focus.

Ray Dothard states that it's not Ray Dothard but the whole Veterans Council he just acts as the chairperson.

### **OLD BUSINESS:**

C/Kuczinski states that he has had conversation and is still working on ambulance service starting 2019. We are working on transition from volunteers to a paid service however we still want to get our volunteers involved. We are always recruiting new volunteers.

M/Dorfman states that other towns are also going through similar outcomes.

C/Grbelja speaks about the proposed warehouses on State Highway 33 and County Road 527A. Our residents are being affected and they have been doing a lot of leg work, they need to get residents from Manalapan involved, since the project is a Manalapan project. Also in Jackson Township there is another proposed park call Trophy Park, it borders Prosper Towns again this is

another project on our boarder and will affect the residents of Millstone. We need to keep Millstone the gem that it is.

M/Dorfman states we, the township committee, our measure of control is within our township once projects are on the outside of our boarders we are only guests, as with the projects on State Highway 33 & County Route 527A in Manalapan and the project on County Route 537 in Jackson. M/Dorfman did appear in Manalapan at the last meeting regarding the warehouse and was coached by our professionals and we asked for some traffic requests it's the same with Jackson and he encourages the residents to get involved. M/Dorfman also speaks about the round-about at Scoters Corner, it is ready to go.

C/Ferro speaks about wildlife and beavers and the damage to roads. There is a meeting scheduled at Fish and Wildlife for December 11, 2018 at 10am at 1 Eldridge Drive.

They all moved here for the environmentally sensitive area that Millstone is. If there is anything else the committee can do for them it would be greatly appreciated.

C/Masci spoke about the incident that happened at the Amazon warehouse and how the facility had to be evacuated. We are very sensitive to our Master Plan - we are not anti building - however we are pro responsible building. C/Ferro asks if they have reached out to any residents in Manalapan that would be against the project, make sure they are aware of the project. C/Masci speaks of the bottlenecking that is now happening on State Highway 33 due to the condo's that have been built in Monroe. C/Grbelja states that some of the housing going up is affordable units and we have worked diligently to meet our affordable housing commitment.
