**WHEREAS**, the Monmouth County Agriculture Development Board is considering the purchase of a development easement on a property located in the Township of Millstone, more specifically identified as:

Raymond and Jean Peplowski: Block 35Lot 11 in Millstone Township, comprising approximately 8.6 acres, with one 0.25-acre nonseverable exception, one 0.75-acre nonseverable exception, zero residences on the net easement area, and zero agricultural labor housing units, all as depicted on Exhibit "A" attached.

**WHEREAS**, N.J.A.C. 2:76-6.7 requires the governing body to review applications for the purchase of development easements as a condition of receiving State Agriculture Development Committee grant funds; and

**WHEREAS**, the Township Committee of the Township of Millstone is aware of the future restrictions on property protected from development as a result of the purchase of a development easement in accordance with the Right to Farm Act and the Agriculture Retention and Development Act; and

**WHEREAS**, the Monmouth County Agriculture Development Board has established a policy of requiring local cost share commitment for all easement purchases; and

**WHEREAS**, the purchase price and certified market value of the agricultural easement is \$35,000 per acre; and

**WHEREAS**, Millstone's anticipated cost share is estimated at 16% of the total consideration, or \$5,600 per acre; and

WHEREAS, Millstone Township will use its Open Space Trust to fund this acquisition; and

**WHEREAS**, certification of the availability of funds is hereby attested to by the Chief Financial Officer; and

**WHEREAS**, the Monmouth County Agriculture Development Board will bear the cost of title searches, surveys, closing expenses and twenty-four percent (24%) of the total consideration; and

**WHEREAS**, the remaining sixty percent (60%) of the total consideration shall be paid by the grant funds from the State Agriculture Development Committee; and

WHEREAS, the use of an Installment Purchase Agreement is not anticipated.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Millstone, County of Monmouth, State of New Jersey does hereby approve and endorse the acquisition of the development easement on Block 35 Lot 11comprising approximately 8.6 acres, with one 0.25-acre non-severable exception, one 0.75-acre nonseverable exception, zero residences on the net easement area, and zero agricultural labor housing units.

WHEREAS, pursuant to the Green Acres Program, the Township initiates steps to protect properties subject to Green Acres restrictions and to compel removal of any encroachments, restoration of the property or to allow minor encroachments upon terms and conditions approved by Green Acres; and

**WHEREAS**, Francis Grigoli is the owner of Block 62, Lot 21.06 as shown on the tax map of the Township of Millstone ("Subject Property); and

WHEREAS, a significant portion of the Subject Property is encumbered by the Conservation Easement in which structures have been constructed, which structures are encroachments violative of not only the Deed establishing the Conservation Easement, but also violative of Green Acres restrictions; and

**WHEREAS**, efforts have been ongoing to effect removal of the encroachments and a restoration of the Conservation Easement area by the owner of the Subject Property; and

WHEREAS, the encroachments remain; and

**WHEREAS**, the Subject Property has been offered for sale and it may be necessary to initiate litigation in order to protect the interests of the Township and of the New Jersey Department of Environmental Protection Green Acres Program.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Millstone as follows:

- 1. The Township Attorney is hereby authorized to continue to pursue an amicable resolution as may be approved by Green Acres.
