19-96 ADOPTION OF THE 2019 MUNICIPAL BUDGET -

M/Masci introduces CFO, Annette Murphy. CFO, Annette Murphy introduces BA Roger Staib, Treasurer/Purchasing Agent Amanda Salerno and Auditor Matt Holman and gives the following Presentation: M/Masci asks Annette to explain what the residents get for their tax dollars, which amounts to \$881 a year or \$73 per month. CFO Murphy states services that the township offers ranges from Building, Construction, Land Use, Dog Licensing, Recreation Programs, Notary, Media, Public Safety, Public Works, Vital Statistics, Community Events and Recycling. The municipal tax levy has been flat over the past 7 years. That can no longer be sustained, however in comparison to nearby towns in Monmouth County, over the same 7 years period their tax levy have risen from 11% to 37%. CFO Murphy asks if there are any questions:

1. Barry Frost - asks about revenue and about the dollars we keep for Court fines. C/Kuczinski states that the activity is the same but we are receiving less dollars. M/Masci states if a person is pulled over on RT 195 we keep less of those dollars compared if a person is pulled over on Millstone Road - it varies.

2.Steve Morelli - asks what do we receive in Code Enforcement revenue - CFO Murphy answers again that is through our Court systems and she does not have those numbers but can get them, please stop by and see Annette. Mr. Morelli asks if there is a breakdown on Construction revenues - again Ms. Murphy does not have those numbers readily available but would be more than happy to go over those numbers in her office.

3. Barry Frost - asks how do we compare to other towns

M/Masci thanks Annette and states that you have outdid yourself, it was a very understandable

M/Masci reads thank you letter from The Watershed Institute thanking Millstone Township once again for participating in the Stream Clean Up. M/Masci states that we will be looking at our fines and looking to put movable cameras on some of our roads. Every day I drive down Prodelin Way and am

so tired of the trash that he sees. We need to do everything we can to stop it. We are going to be aggressive.

NEW BUSINESS:

1. The widening of Baird Road has been something the township has been working on with the County - if you've ever driven over the bridge there you know it's a bottleneck. Pat Butch has played a key roll - so thank you Pat - for all your hard work, this wouldn't have gotten done without you. There will also be a beautiful trail for the students to use to cross from the school property to the Thomas Baird Homestead.

2. C/Grbelja states there will also be a pedestrian walkway, which will be really helpful. The Baird Road areas is very tight and Pat Butch has advocated for the students to have a safe travel path from the school to the Thomas Baird Homestead. Baird Road is extremely dangerous, there is excessive speeding on the road. We just has a loose horse and dog on the road - people need to slow down. 3. M/Masci states that if you have not had a chance to sign the petition regarding the school state aid that has been cut, please sign by Tuesday as C/Dorfman along with School Superintendent Huss will be going to Trenton to meet with the State Education Commissioner, thank to our legislatures for arranging the meeting. The petition is available at town hall also at Albivi, Vesuvio, our Website and at the schools.

4. C/Ferro reminds everyone about the Memorial Day Parade, which will take place on Monday, May 27th. at 9:00am. Please come out and honor our veterans, first there will be a large parade which will include motorcycles, old cars and horses along with many other organizations. Then at Blackbear there will be food available to all compliments from Blackbear and Vesuvios.
