1. Diseased Trees - BA Staib discusses with the committee the number of diseased Ash Trees around the township. They are both on Township and Public Property. This needs to be addressed, we need to keep an eye on the situation and if anyone has any ideas on how we proceed please bring them forward. M/Masci states that when DPW is out on the roads and they see signs of compromised trees or any safety issue with trees they let us know. BA Staib will send a letter to DPW informing them of this. C/Grbelja states in the past we worked with a consultant who worked with our Shade Tree Commission, it's a big loss that she is no longer working with us - we should look into bringing her back. M/Masci states that JCP&L is doing a area survey - is there any way they might be able to inform us. C/Kuczinski states that JCP&L hires sub contractors to prune maybe they can advise. M/Masci states that we need to educate the residents, maybe post on our website. C/Grbelja states we have worked in the past

with Shared Services with Monmouth County on aerial spraying. BA Staib states that when DPW is out pruning there is only so much that they can do with their equipment. C/Dorfman states that we need to remind the citizens to be good neighbors and trim back shrubs that may impede sight lines.
