Robert Munoz, Township Attorney read **Resolution 19-161** in full:

Resolution Authorizing the Execution of a Memorandum of Understanding and an Extension of the Current Mining Permit for Buck Mining and Materials, Inc., Block 28, Lots 11 & 13.01:

**WHEREAS**, Buck Mining and Materials, Inc ("Buck") is the owner of a surface mine property, Block 28, Lots 11 and 13.01 ("Property") located within the Township; and

**WHEREAS**, the Township has supported the preservation of the Buck surface mine for public park and recreation purposes by the County of Monmouth; and

**WHEREAS**, Buck has expressed an interest in the preservation of its property in a letter to Robert F. Muñoz, Esq., the Township Attorney, dated May 13, 2019 (a copy of which is attached

hereto as Exhibit "A"), from William and Lesley Stone outlining a plan to prepare the Property for preservation; and

**WHEREAS**, the Township and Buck desire to outline the mutual expectations and requirements in this Memorandum of Understanding ("MOU") to accomplish preservation of the Property and preparation for same to become a public park, a copy of which is attached hereto.

**WHEREAS**, the MOU has been reviewed and approved by the Township's Mine Engineer and the Township's Mine Engineer has approved the terms and conditions of the work to be performed; and

**WHEREAS**, it is the recommendation of the Township Mining Engineer that the current mining permit of Buck Mining and Materials, Inc. be extended as set forth in the MOU.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Millstone as follows:

- 1. The Mayor and Deputy Clerk be and are hereby authorized to execute and deliver the attached MOU.
- 2. The current mining permit of Buck Mining and Materials, Inc. be and is hereby extended for a period as provided in the MOU, subject to the terms and conditions of the MOU.
- 3. The Township's Mine Engineer be and is hereby authorized to assure compliance with the MOU by Buck Mining and Materials, Inc.

## **NEW BUSINESS:**

Mayor Masci discusses the upcoming 4<sup>th</sup> of July celebrations and fireworks. Mayor Masci reminds residents that we live in a community having numerous types of animals that are very sensitive to explosions. We also have homes that are surrounded by trees and leaves on the ground which could catch on fire from shooting off fireworks. Mayor Masci stressed to the residents to leave the fireworks to the professionals and reminds the residents about the fireworks ordinance adopted by the Township Committee. Mayor Masci encourages residents to contact the State Police about anyone shooting off fireworks and that homeowner will be issued a summons.

DM/Grbelja agrees with the Mayor and states it is definitely a problem with the same habitual residents who are inconsiderate of their neighbors and hope the State Police issues summons. DM/Grbelja reminds residents that there are a lot of out of state cars traveling through the town going to Great Adventure using the GPS or apps on their phones. They are speeding, passing cars and hassling farmers who are trying to get to their fields by bumping into their equipment which has caused several accidents. DM/Grbelja will look into some court cases that will try to limit some of the GPS companies from coming through the town. DM/Grbelja has made suggestions on curbing the situation and also will be investigating some other alternative solutions.

Mayor Masci states that the Business Administrator, Roger Staib, has reached out to the County and is looking into a shared service with a law enforcement agency that would monitor certain areas at certain times. Mayor Masci has spoken to the Judge about fines associated. Most important drive safely!

## **OLD BUSINESS:**

DM/Grbelja spoke about the excellent presentation that the Ag Council sponsored on Deer Tick and Invasive Species. The presenters, Dr. Kelly and Dr. Egizi, were very good and informative.

C/Dorfman states that it was two excellent presentations. The first presenter spoke about forestry and the life cycle of a forest. The data was very compelling, which goes back 100 years. This data tells you what should be growing in areas throughout the town. We now have a dysfunctional forest that is not generating the new growth which impacts the entire cycle. This all ties back to lack of deer management. The second presenter spoke about tick and tick related diseases. Ticks are transported by the deer. Many residents have been affected by deer whether by car accident or tick related diseases. The Township will have to move forward with deer management in the community for the health, safety and welfare of our citizens.

Mayor Masci spoke about a meeting DM/Grbelja had about deer management and the township will have to take some type of action. The Township Committee members are all sensitive to wildlife, but there needs to be a balance. Dr. Kelly's power point presentation will be posted on the website.
