NEW BUSINESS:

- 1. Recycling Containers Business Administrator discusses the possibility of the municipality to purchase recycling containers (32 gallon) and how to handle the distribution to residents. The recycling contract has increased considerably and there was only one bidder. The Township Committee discusses the increase. DM/Grbelja states that in the December newsletter, there is information on single stream recycling and what is mandated and not accepted.
- Strategic Planning The Township Committee will start looking at 1, 3- and 5-year strategic planning and prioritize projects. DM/Grbelja said that we need to take a look at the budget. Preliminary discussion is to update the software for the Construction, Land Use, Tax and Zoning Offices; Smartboards for presentations; building maintenance needs; possible consolidation and determine the needs of the residents.

OLD BUSINESS:

1. LED Signage – Business Administrator said that Monmouth County has put signs up at Stillhouse Road and Stagecoach intersection. The County was contacted and the signs can be removed and replaced with the LED stop signs the Township is considering. The Township

Committee discusses the options, possibly paint stop ahead on pavement, put a strip of LED lights on the stop sign pole or put up the LED stop sign or stop ahead sign.

DM/Grbelja attended the Eagle Scout Ceremony this past weekend and congratulates Luke DePinho Jordan Lisnow, Nicholas Meier, Noah Meier, Andrew Raccuglia and Jared Scott Skidmore on meeting their requirements for Eagle Scouts.
