Unfortunately, we are still waiting to get guidance from the State which is expected to come out next week. Andrew DeFelice, Recreation Coordinator has been doing a tremendous job working on this. Frog Bridge and Black Bear camps are closed for the season. We are trying to do something, maybe mini programs which would have limited number of participants and hours.

G/Dorfman also states that he will be reaching out to the Township Committee get their thoughts and guidance on Millstone Day.

M/Masci states the Governor Murphy is looking out for the safety and well being for the residents. However, he has lost credibility to fairness. How can some businesses be able to do social distancing and how others businesses can't. This is not fair. He asks the Governor to change his executive orders and be fair to all businesses. This is killing people's livelihood and this must change.

C/Kuczinski agrees it is unfair and lopsided. Businesses can't make it. The Governor should put a program in place to help these businesses salvage what they have and to be able to slowly come back.

C/Dorfman states that our country has the Constitution and Bill of Rights. Each and every one of us has a choice to go where we want to go or not and it is not the Governor telling us.

Business Administrator states that Millstone has joined with the Affordable Housing Alliance a Housing Rehabilitation program that will give up to \$15,000 for rehabilitation/repairs to your home. This program is based on income and an application (coupon) needs to be completed and mailed to Affordable Housing Alliance. The coupon is on the Township website and also placed around the Township.
