WHEREAS, in an effort to more fairly assign greater fiscal responsibility to delinquent taxpayers, the Township of Millstone wishes to charge \$25.00 per notice mailed which will be assessed specifically to the delinquent accounts that are causing the need for a tax sale and not to the general tax base.
