# A RESOLUTION APPROVING AN AMENDED AFFORDABLE HOUSING SPENDING PLAN FOR THE TOWNSHIP OF MILLSTONE

WHEREAS, on September 5, 2019, the Township of Millstone ("Township" or "Millstone") entered into a settlement agreement with Fair Share Housing Center ("FSHC Settlement Agreement") which established the Township's fair share obligation and preliminarily approved the Township's compliance mechanisms in accordance with the March 10, 2015 decision of the New Jersey Supreme Court, In the Matter of the Adoption of N.J.A.C. 5:96 and 5:97 by the New Jersey Council on Affordable Housing, 221 N.J. 1 (2015) ("Mount Laurel IV") which transferred responsibility to review and approve Housing Elements and Fair Share Plans from the Council on Affordable Housing ("COAH") to designated Mount Laurel trial judges within the Superior Court; and

**WHEREAS**, on March 18, 2020, the Township adopted a Spending Plan which projected anticipated revenues and expenditures from the Township's Affordable Housing Trust Fund, consistent with the FSHC Settlement Agreement, and thereafter secured Court approval of its Spending Plan, pursuant to N.J.A.C. 5:93-5.1 et., seq. and consistent with P.L.2008, c.46 and Council on Affordable Housing ("COAH") regulations;

**WHEREAS,** on July 5, 2023, the Township entered into an amendment to the FSHC Settlement Agreement.

**WHEREAS**, the Township Affordable Housing Planner, McKinley Mertz, PP/AICP of Heyer Gruel & Associates has prepared a revised Spending Plan to implement the amendments to the Housing Element and Fair Share Plan to satisfy the amendment to the FSHC Settlement Agreement.

WHEREAS, the Township requires approval of its revised Spending Plan in order to ensure that all expenditures from the trust fund are in accordance with the approved revised Spending Plan.

**NOW THEREFORE BE IT RESOLVED,** the Governing Body of the Township of Millstone, County of Monmouth, and the State of New Jersey hereby adopts the revised Spending Plan that is attached hereto as **Exhibit A** and requests its Affordable Housing Counsel take the necessary steps to seek Court approval of same, so that all expenditures from the trust fund are in accordance with an approved Spending Plan.
