# RESOLUTION APPOINTING HISTORIC PRESERVATION ARCHITECT AND AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES

WHEREAS, the Township of Millstone requires a Historic Preservation Architect to perform an assessment and assist with the historic grant for the Clarksburg School which is on the National Register of Historic Places; and

**WHEREAS**, such specialized services can only be provided by licensed professionals and Barton Ross, AIA, AICP, LEED AP of Barton Ross & Partners LLC is so recognized; and

WHEREAS, Barton Ross, AAIA, AICP, LEED AP has submitted a proposal dated February 28, 2023 to provide an assessment and assist with the historic grant for the Clarksburg School; and

WHEREAS, Barton Ross & Partners LLC has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Millstone in the previous one year, and that the contract will prohibit them from making any reportable contributions through the term of the contract; and

**WHEREAS**, the architecture firm of Barton Ross & Partners LLC has completed and submitted a Political Contribution Disclosure form in accordance with P.L. 2005, c271; and

WHEREAS, this contract is awarded as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5, for the period of March 1, 2023 through December 31, 2023 for an amount not to exceed \$3,500.00; and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. requires that notice with respect to contracts for professional services awarded without competitive bids must be publicly advertised; and

**WHEREAS,** the Chief Financial Officer has certified that funds are available in account T-16-56-100-030.

**NOW THEREFORE, BE IT RESOLVED** that the Township of Millstone does hereby authorize the award of a non-fair and open contract for professional services, for the period of March 1, 2023 through December 31, 2023, and appoints Barton Ross, AIA, AICP, LEED AP of Barton Ross & Partners LLC as Historic Preservation Architect, for an amount not to exceed \$3,500.00.

**BE IT FURTHER RESOLVED** that this contract is awarded without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i) because it is for services performed by persons authorized by law to practice a recognized profession.
