WHEREAS, Jeffrey Surenian, Esq. has submitted a proposal dated April 6, 2023 to provide special counsel services with respect to Affordable Housing Obligations; and

Surenian Esq., Michael J. Edwards, Esq. or Edward J. Buzak, Esq; \$190.00 per hour for Erik C. Nolan, Esq., \$175.00 per hour for the Firm's associates: Christine M. Faustini, Esq., Nancy L. Holm, Esq., William E. Olson, Esq., Susan L. Crawford, Jacqueline Gioioso, Esq., Keli L. Gallo, Esq; and \$90.00 per hour for paralegal work; and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. requires that notice with respect to contracts for professional services awarded without competitive bids must be publicly advertised; and
